

## **BLACK FRIDAY RAFFLE COMPETITION**

1. In this Terms & Conditions, unless the context requires otherwise, the following words shall have the following meanings:

"Competition" means the Black Friday Competition

2. BLACK FRIDAY COMPETITION:

As a Competitional offer for Black Friday 2020 the Company is giving away an iPhone 12, an iPad and a Smart Watch. In order to be eligible to enter the Competition you need to meet the following criteria:

- a. This Competition begins on the 20<sup>th</sup> of November 2020 and is valid until the 30<sup>th</sup> of November 2020;
