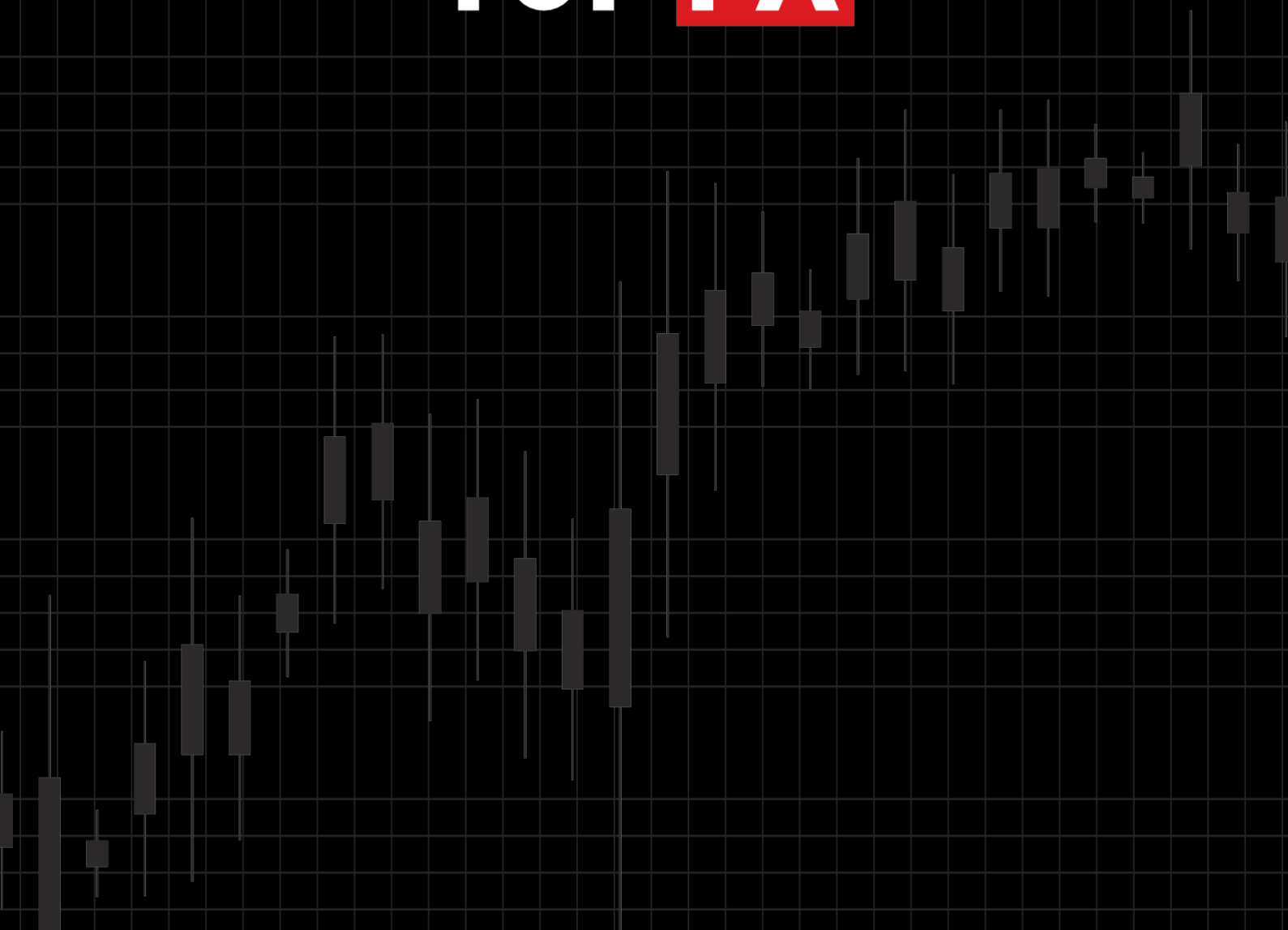

## Terms and Conditions

### TopFX Global Ltd: Vietnam Traders Fair Raffle Competition

#### Criteria:

1. Attend the Event
2. Open a Live Account with TopFX.
3. Submit KYC particulars during the Event.

#### A. Introduction

1. TopFX Global Ltd (hereinafter called the “Company” or “TopFX”) is a company registered under the Laws of Seychelles with registration number 8424819-1 and is licensed with a Securities Dealer License by the Financial Services Authority (“FSA”) of Seychelles under the License No: SD037.
2. The Vietnam Traders Fair Raffle Competition (hereinafter called the “Raffle Competition”) Terms and Conditions is an integral part of the TopFX Terms of Business (available at <https://topfx.com.sc/pdfs/TopFxTerms&Conditions.pdf>) and provisions set herein are considered as an Annex of these terms. By participating in this Raffle Competition, the participants acknowledge that they have read and agreed to be bound by these Terms and Conditions (hereinafter called the “T&Cs”) as well as to the general terms and conditions that apply to their account.

#### B. General Provisions

1. The Raffle Competition will take place on the 10<sup>th</sup> of December 2022 after the end of Vietnam Traders Fair Event (hereinafter called the “Event”) for clients of TopFX who satisfy the eligibility criteria set herein.
2. This Raffle Competition is available only to new clients who meet the following conditions (hereinafter referred to as the “Eligible Clients”):
  - a. Attend the Event.
  - b. Open a live trading account with TopFX.
  - c. Submit their KYC particulars during the Event.
3. The one (1) winner will be announced at the end of the Event.
4. The winner will be selected randomly through a randomizer and will be announced at the end of the Event on the 10<sup>th</sup> of December 2022.
5. The prize of the competition is 500 USD (hereinafter called the “Prize”) which will be credited in the winner’s TopFX trading account as equity.
6. The amount of the Prize is added to winner’s TopFX live verified trading account upon the winner’s

request (via email at [support@topfx.com.sc](mailto:support@topfx.com.sc)). Please note that in case that the winner's account has not been verified he/she will not be able to claim the Prize and the Company reserves the right to select a new winner from the Eligible Clients following the same procedure (i.e. through randomizer). Please note that, subject to the provisions set herein, the winner has a maximum period of 48 hours from the date that he/she will be announced as a winner to verify his/her account.

7. Please note that the Prize amount (i.e. 500 USD) is withdrawable provided that the winner has traded at least five (5) lots in any instruments following the addition of the Prize in his/her TopFX trading account.
8. The Prize amount is for trading purposes and the Company does not guarantee the payment of the whole amount (i.e. 500 USD) to the winner since this amount is subject to losses that the winner may suffer during trading. More specifically in case that the winner suffers any losses of the said Prize amount during trading then, he/she will be able to withdraw the remaining Prize amount. That is in case that the winner has traded five (5) lots and losses 300 USD he/she will be able to withdraw the remaining 200 USD. If the winner loses all the Prize amount he/she will not be able to withdraw anything.
9. Subject to the conditions set herein, the profits of trading with the Prize amount, if any, are also withdrawable. That is, in case that the winner earns 300 USD after trading at least five (5) then he/she will be able to withdraw 800 USD (i.e. 500 USD Prize amount + 300 USD profits).
10. The Prize is non-transferable, non-refundable, and cannot be exchanged for any cash alternatives in whole or in part.
11. The winner will have 48 hours to claim the Prize from the date that he/she will be announced as a winner (i.e. 10<sup>th</sup> of December 2022). After the expiration of the said timeframe and provided that the winner has not claimed his/her Prize, the Company reserves the right to select a new winner following the same procedure (i.e. through randomizer).

### **C. Reservations of Rights and Disqualifications**

1. The winner must provide true and accurate information. The Company reserves every right to request more documentation if deemed necessary to be satisfied as to the winner's identity prior to providing the gift to the winner. If the winner is found to have provided false documents even after the gift is given, then the gift shall be returned to the Company.
2. We reserve the right to provide an alternative prize of equal or greater value in the event of any unforeseen circumstances.
3. We reserve the right to exclude any entry if it comes to the Company's attention any abusive behavior by any of the participants to this Competition. Eligible Clients who provided incorrect and/or fraudulent details during the trading account registration and/or during the Event will be disqualified from the Raffle Competition.
4. Eligible Clients who have been disqualified lose their right to claim the prize offered.
5. By taking part in this Raffle Competition, all participants consent to us collecting, storing, and using their personal data submitted with their entries for the purposes of this promotion.
6. Any personal data relating to participants will be used solely in accordance with the personal data protection legislation and will not be used for marketing purposes without the individual's prior consent.
7. TopFX reserves the right, at its sole discretion, to alter, amend or terminate this Competition, or any

aspect of it, at any time and without prior notice. The Company recommends that the participants revisit these T&Cs regularly and by their continued use of the Company's services, the participants accept any such modified terms.

8. The Company reserves the right to withdraw or amend without notice this Raffle Competition in the event of any unforeseen circumstances outside of its reasonable control.
9. Notwithstanding any other provision of these terms, the Company shall have the sole discretion to determine the participant's eligibility under these terms, including, without limitation, whether the participant is eligible or not. The Company has the right not to accept a participant for any reason as the Company shall determine in its sole discretion.
10. If these terms are translated into a language other than English, then the English version shall prevail whether there is any discrepancy or inconsistency.
11. Any dispute or situation not covered by these terms will be resolved by the Company's Management in a fair manner.
